Understanding the Intersection of Title I, Part D & McKinney-Vento

- Title I, Part D: Supports neglected, delinquent, and at-risk youth.
- McKinney-Vento: Ensures educational access for homeless students.
- Common Challenges:
- High mobility disrupting learning.
- Lack of access to resources and support systems.
- Coordination gaps between education and juvenile justice systems.

Actionable Strategies for Strengthening Collaboration

- Establish a Cross-Program Task Force:

- Align Funding Streams:
- Identify overlapping service areas.
- Ensure efficient use of available resources.
- Develop Data-Sharing Agreements:
- Secure student transition data between facilities and schools.
- Improve early intervention and tracking of student progress.

Partnerships That Enhance Transition Services

- Strengthening Collaboration:
- Build partnerships between LEAs, AL DYS, and community organizations.
- Creating Seamless Educational Transitions:
- Develop consistent reentry plans for students leaving juvenile facilities.
- Mentorship and Support Programs:
- Implement peer mentorship initiatives.
- Connect students with academic and social-emotional support.

Practical Examples & Success Stories from Alabama

• Case Study 1: A student's transition from a juvenile facility back to public school.

A 16-year-old McKinney-Vento eligible student, who experienced housing instability while in custody at the Alabama Department of Youth Services, successfully transitioned back to a public school setting. With coordinated efforts between the facility's transition specialist, the local McKinney-Vento liaison, and district support staff, the student received immediate enrollment, academic placement, and transportation services. This collaborative approach ensured continuity of education and access to wraparound supports, resulting in increased school engagement and stability.

Practical Examples & Success Stories from Alabama

• Case Study 2: Impact of professional development sessions on educators.

Educators within the Alabama Department of Youth Services participated in targeted professional development focused on trauma-informed instruction, restorative practices, and culturally responsive pedagogy. These sessions enhanced staff capacity to recognize and respond to the complex needs of justice-involved youth. Educators reported an improvement in student behavior, stronger student-teacher relationships, and more inclusive classroom environments tailored to youth impacted by trauma and disruption.

Practical Examples & Success Stories from Alabama

• Outreach Initiatives: Community-driven efforts to support at-risk youth.

A McKinney-Vento student with prior involvement in the juvenile justice system benefited from a local outreach initiative spearheaded by community partners, including shelters, youth advocates, and mentorship programs. This initiative provided critical resources such as stable temporary housing, school supplies, mental health counseling, and career readiness workshops. By leveraging community support and interagency collaboration, the student maintained school stability, reconnected with a caring adult mentor, and began planning for postsecondary education.
